"TERMS AND CONDITIONS" 2021 HRBC YEARLING SALE



The following policies and options for consignors are in effect and will apply to the 2021 HRBC Yearling Sale to be conducted on **October 26th**, **2021** in the Agriplex building across from Fraser Downs backstretch.

It is the <u>consignor/agents responsibility</u> to be aware of these policies, practices and procedures.

In entering a horse in the HRBC Yearling Sale, the owner(s)/consignor(s)/agent(s) agree to the following.

- 1. The horse must be microchipped by all regulations of Standardbred Canada.
- 2. Horses that are electronically registered MUST provide the HRBC office with a signed transfer showing signatures of ALL owners of the horse; if Paper Registered, all owners must sign the back of registration and submit to the HRBC Office **no later than Friday, October 15th, 2021.**
- 3. Horses must have a **Negative Coggins Test Certificate** with copy on file with HRBC prior to the sale. Due to racetrack rules/procedures, any yearling arriving at Fraser Downs Racetrack and Casino, may be turned away and not permitted access to the property. This would result in the immediate withdrawal of the yearling and penalties including but not limited to the Withdrawal policy will be applied.
- 4. All purchases are final on an as seen, inspected, and accepted basis.
- 5. HRBC will not be responsible to any buyer, consignor, or horse owner for any changes to purses, conditions, locations, or information pertaining either to the horse / event; or for cancellation thereof, which may occur after a horse is entered in this Sale; or for any changes to bonus programs funded by HRBC.
- 6. Minimum Bid is 1,000 + GST = 1,050.00 + 5% commission will be charged on this amount, even if there is no bid. Opening bids lower than 1,000.00 will not be accepted.
- 7. Reserve Bid Please refer to the Reserve Bid Policy and Procedure form for details. The reserve bid must be in and accepted by the HRBC Sales Representative, Diane Pennington no later than the day before the sale. Commission will be charged on the amount of the reserve bid. Once the reserve amount is achieved and approved by the auctioneer, the consignor may not continue to bid on the yearling.
- 8. GST on commission will NOT be paid to consignors who do not provide a GST number.
- 9. Authorized Agents must complete the "<u>Authorization of Agent</u>" form and submit completed form to the HRBC Office **no later than 10:00 am on Sale Day**.
- 10. A Withdrawal Policy will be in effect for the 2021 sale. Horses withdrawn from the sale may only be withdrawn with a certificate issued by a **HRBC approved veterinarian**. A separate withdrawal fee of <u>\$500.00</u> will apply if this HRBC veterinarian certificate is not obtained.
- 11. Harness Racing BC reserves the right to cancel the Sale should it determine that insufficient entries have been received.
- Horses can enter the Agriplex on Monday, October 25.2021 after 2:00 pm and viewing for all horses will be on Tuesday, October 26, 2021 at noon providing set up has been completed.
 All horses must be removed from the Agriplex on Tuesday, October 26, 2021 no later than 11:00 pm.

NOTE: ENTRIES must be in by July 15th, 2021. PAYMENT must be received by 3:00 pm on August 1st, 2021. Any entry received without payment will not be published to the catalogue, nor will it be posted to the HRBC Website or sale page. Failure to submit payment WILL result in removal of entry from sale.
