2022 BC RESIDENT MARE ENROLLMENT

Each year a percentage of the allocation funds from all streams of revenue are allocated specifically to support BC Bred Standardbreds. Funding is reviewed by the HRBC Board of Directors on an annual basis and adjustments are made according to funding and success of programs.

The Standardbred Resident Mare Program is to focus on the Breeding and Ownership of Standardbred Mares in the Province of British Columbia.

CONDITONS:

When the owner of a mare registers a BC Bred foal with Standardbred Canada and has the mare registered in the 2022 BC Resident Mare Enrollment program, they are eligible to apply for the BC New Foal Incentive Grant issued by Harness Racing BC. By enrolling the mare (s) that you have listed on the BC Resident Mare Enrollment form, you certify that the said mare (s) is a BC RESIDENT MARE and agree to comply to the conditions as listed.

1. In order for HRBC to have an accurate number of the mares that are in BC for that given year, HRBC is asking all breeders to enroll their mares, in foal or not.
2. To be eligible for these programs, all recipients must be a paid up member of Harness Racing BC in good standing.
3. HRBC, within its sole discretion may from time to time make changes to the terms, conditions and financial structure of all HRBC funded programs and incentives, approve or decline application and the HRBC member hereby agrees to be bound by such changes.
4. Mares must be registered with Harness Racing BC for the foal to be eligible to the 2022 BC New Foal Incentive.
5. Additional information may be required; therefore, please keep receipts showing shipping etc., in the event to be reviewed by Harness Racing B.C.
